THE PORTLAND CLINIC SUMMER OF COLOR SWEEPSTAKES

Official Rules – UPDATED ON AUGUST 5, 2016

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Portland Clinic Summer of Color Sweepstakes ("Promotion") begins June 13, 2016 at 9:00:00 a.m. U.S. Pacific Time ("PST") and ends on August 14, 2016 at 11:59.00 p.m. PST ("Promotion Period").

The Promotion is sponsored by The Portland Clinic ("Sponsor") and administered by CMD ("Administrator") and is open to and is open only to legal residents of Oregon and Washington, who are at least eighteen (18) years of age and have reached the age of majority in their home states at the time of entry. Void outside of Oregon and Washington.

1. How to Enter

Facebook and Twitter Method

To participate, you must have or create a Twitter or Facebook account ("Twitter or Facebook account") and enable privacy settings for sweepstakes entry posts or tweets as "Public." If you already have a Twitter or Facebook account, you will have to sign in to your account. If you are not an existing member of Twitter or Facebook, you will be required to follow the directions and join Twitter or Facebook. When you join Twitter or Facebook, you are indicating that you have read and agree to accept the Twitter or Facebook Terms of Service and Privacy Policy. Membership to Twitter.com and Facebook.com is free.

Entrants must visit <u>http://bit.ly/ColorPortland</u> and download of one (1) of three (3) The Portland Clinic provided pictures to color (the "Coloring Project"). Coloring Projects can also be picked up at any of the six The Portland Clinic locations.

To enter, sign into your Facebook or Twitter account and complete the following steps:

- 1. Download or pick up the coloring project of choice.
- 2. Color the coloring project and take a photograph of the completed work.
- 3. Include the photograph in the post or tweet.
- 4. Use the hashtag #ColorPDXSweepstakes

Once all of the above steps are completed, you are automatically entered into the drawing(s).

Regardless of which platform you use to enter, each entrant may submit one (1) entry per coloring project of choice for a total of three (3) entries during the entire Promotion period.

Free Alternative Method of Entry

Alternatively, you may hand print your name, address, email address, and age on a 3" x 5" index card and mail it in an envelope with proper postage to 1631 NW Thurman Street, SUITE 400, Portland, Oregon 97209. For each mail-in request, you will be entered once into the random drawing for the individual Promotion indicated on your entry card. Limit: one entry per envelope; three (3) entries during the entire Promotion period. All mail-in entries must be handwritten. All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. All mail-in entries must be postmarked by August 16, 2016.

2. Prizing

Three (3) \$100 Gift Cards will be awarded. One (1) card for each of the three (3) coloring project drawings.

- One \$100 gift card to Dutch Bros. Coffee will be awarded to the winner of the "Coffee" coloring project.
- One \$100 gift card to Next Adventure will be awarded to the winner of the "Shoe" coloring project.

The Total Approximate Retail Value (ARV) of all prizes is \$300.00 USD.

3. Prize Drawing

The Sponsor will randomly select one (1) winners from each of the three (3) coloring project entry pools. Three (3) total winners (subject to verification) will be selected. The drawings will be held on August 22, 2016. Winners will be notified via email with further instructions on how to claim prizes by August 25, 2016.

Only one Prize per individual or family will be awarded during the Promotion Period. Winners are solely responsible for all federal, state, and local taxes and all unspecified expenses or fees associated with prize acceptance, receipt and use. No substitution, assignment, or transfer of prizes permitted, except by Sponsor, who reserves the right to substitute a prize/prize component with another prize/prize component of greater or equal value if prize/prize component cannot be awarded as stated for any reason. Sponsor's computer is the official clock for purposes of the Promotion.
